01/01/2018 Private Passenger Rate Revision



Effective 01/01/2018 MAIPF will implement a Private Passenger base rate revision and a revision to the per-vehicle amounts for additional charges to PIP. The base rate revision has an overall impact of +13.5%. The increase is being driven by new territory definitions that have been decided by ISO. The territory codes will no longer be manually selected. They will be based on zip codes that have been defined by ISO.

02/01/2018 Commercial Rate Revision

Effective 02/01/2018 MAIPF will implement the following Commercial base rate revision.

02/01/2018 Commercial Risk Classification Update

In an effort to provide accurate risk classifications, we will be implementing Car Services as a new risk type effective 02/01/2018. Car Service will include an unmetered auto, other than a taxicab or limousine, with a seating capacity of eight or less that is operated for hire by the named insured or employee, and operates from a central base station. The auto must be licensed by the appropriate licensing authority, as required by law, based on the territory of operation.



Citizens Insurance Withdrawal

We have successfully completed the transfer of the in-force policies that were with Citizens Insurance. Each policy that was not placed in the voluntary market has been renewed with our other active Servicing Carriers. We appreciate the assistance and patience of each producer we worked with during this transition.

Quick Quote Removal

Effective 01/01/2018, the Quick Quote option on the Producer Tools page of the MAIPF website will be removed. The same capabilities are provided under our Private Passenger rating system, EASi. In order to quote a change, you can select "Create New Quote or Application" and proceed through the Quick Quote section of the application.

NOTE: Please do not submit a new application for each change. This is to be used for quoting purposes only. Once you have the change in premium, please fill out the MAIPF-36 Policy Change Request Form. This form, along with 40% of the additional premium, or \$100 (whichever is greater), needs to be mailed to the Servicing Carrier the application has been assigned to.
